Sir/Madam,

With reference to the letter cited above, I am directed to inform you that the University has fixed the schedule for admission to **U.G. CBCS Semester-I (Session 2026–30)** from **16.06.2026 to 19.06.2026**.

In order to streamline the registration process and ensure strict compliance with the **Uniform Academic Calendar** issued by the Additional Chief Secretary to Governor vide Letter No. **BSU (Directive)-43/2023 (Part-2)-1037/GS(I)** dated **29.05.2026**, the **Registration Process of the students shall commence simultaneously with the admission process.**

Accordingly, all Principals are requested to ensure the following:

1. During the physical verification of documents, students shall be required to submit their **Migration Certificate in original**.
2. The colleges shall collect a **Registration Fee of Rs. 600/- (Rupees Six Hundred only)** from every student submitting the original Migration Certificate for registration.
3. The total Registration Fee so collected shall be remitted to the Office of the Deputy Registrar (Registration), Purnea University, Purnia, **immediately after completion of the admission process**, through a **Demand Draft drawn in favour of "Registrar, Purnea University, Purnia"**.
4. The Demand Draft must be accompanied by the detailed particulars of the admitted students in the **prescribed format**.
5. The colleges shall also obtain and record the students' choices of **MIC (Minor Course)**, **MDC (Multidisciplinary Course)**, **VAC (Value Added Course)**, **SEC (Skill Enhancement Course)**, and **AEC (Ability Enhancement Course)** in the



prescribed format and preserve the same carefully for future use during the online course selection process through the **SAMARTH Portal**.

All Principals are requested to ensure meticulous compliance with the above instructions so that the registration process is completed smoothly and within the stipulated timeline.
